In terms of Section 14(1) of the NCTE Act, 1993 **Don Bosco College of Teacher Education**, **At/P.O. Tura, Dist. West Garo Hills, Meghalaya, Pin – 794 002** had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2004 (starting from January, 2004) with an annual intake of 100 (One hundred) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - i) The institution has acquired the land for setting up the teacher education institution.
 - ii) The institution has made arrangements for conducting the course in one wing of the own building of the management for the proposed institution.
 - ii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. 3.00 lakhs
 - iii) The institution has selected the Principal-cum-Secretary (on ad-hoc basic) and 07(seven) teachers for the said course and the list of faculty members has also been approved by the affiliating University i.e. Director, College Development Council, North Eastern Hill University, Shillong.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to <u>Don Bosco College of Teacher Education</u>, <u>At/P.O. Tura, Dist. West Garo Hills, Meghalaya, Pin 794 002 for B.Ed.</u> Course of <u>one</u> year duration from the academic session <u>2005</u> (starting from January, 2005) with an annual intake of <u>100 (One hundred)</u> students subject to fulfillment of the following:
 - a. That the institution will ensure that **Principal** and at least **07** (seven) faculty members qualified as per NCTE norms duly approved by the affiliating University i.e. Registrar, North Eastern Hill University, Shillong are in position for an intake of **100** (One hundred) students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
 - b. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.

- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS the institution viz. Don Bosco College of Teacher Education, Tura, West Garo Hills, Meghalaya—794 002 was granted recognition for conduct of B.Ed. course of one year duration with an annual intake of 100 from the academic session 2005 vide ERC order no. ERC/7-40(ER)-40.4.1)/2003/3415, Dt. 12.12.2003.
- 3. AND WHEREAS, the institution viz. Don Bosco College of Teacher Education, Tura, West Garo Hills, Meghalaya—794 002 has by affidavit dated 27.01.2015 consented to come under New Regulations 2014 and sought for two basic units in B.Ed. course which require additional facilities.
- 4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfilling following conditions namely,
 - (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional fund, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
 - (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 5. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to **Don Bosco College of Teacher Education**, **Tura**, **West Garo Hills**, **Meghalaya-794 002** for conducting **B.Ed.** Programme of **two** years duration with an annual intake of 100 for two basic units of 50 student from the academic session **2015-2016** subject to fulfilment of the conditions mentioned herein before 31.10.2015.
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. If it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
